Please ask for Taxi transfer from airport Faro to your accommodation/ Please ask for Car Hire. We highly recommend that if you intend to travel by taxi from the airport to your accommodation that we pre-book a taxi on your behalf. It will be cheaper! Especially if there are more than 4 passengers.

Please read these booking conditions carefully as they together with the specific information about your confirmed accommodation, form the basis of your accommodation with the owner and you will be bound by them. In these booking conditions “we”, “us” and “our” means the company, IfVilamoura, that rent on behalf of the Owner. “You” and “your” means the group leader and all persons named under the booking.

1. Booking

Please complete this Booking Form, sign and send back by email, together with a 1st bank transfer or payment of the villa price. Please note that your period is definitely only after receipt of your deposit payment and remittance of our Booking Confirmation. Final Payment is due as agreed.

2. Prices

We reserve the right to alter any of our accommodation priors. We also reserve the right to correct errors in both advertised and confirmed prices. You will be advised of the current price of the accommodation that you wish to book before booking form is confirmed.

3. Your responsibility for your booking

When you make the booking you guarantee that you have the authority to accept and do accept on behalf of your party the terms of these booking conditions. This means that you are responsible for making all the payments due, notifying us if any changes or cancellations are required and for receiving the confirmation and keeping your party informed.

4. Cancellation

a) Cancellation by you – Cancellation must be in writing by lead name and sent to us by recorded delivery. Should you cancel after making the full payment or the first payment, there is no refund on the villa price.

b) Cancellation by us – In the very unlikely event that specific accommodation ceases to be available as booked and we are unable to offer you equivalent alternative accommodation we will refund you all the money paid.



c) Force Majeure – If cancellation or change by us is brought about by war, threats of war, riots, civil commotion, strikes, disasters, natural disasters, terrorist activities, acts of any government or public authority, acts of God or other events outside our control we shall not be held responsible in any way.

4. Damage Deposit

A breakage deposit is required to cover against breakage, loss damage or otherwise abuse of the property, its contents, fixtures, fittings and equipment. We reserve the right to request this bond at any stage up to and including arrival at the property. Failure to pay the breakage deposit upon request will result in your booking being treated as cancelled by you. Notwithstanding the breakage deposit held, you remain liable for the full cost of any repairs or replacements required due accidental or negligent breakage, loss or otherwise abuse of the property. The villa is checked prior to your arrival to ensure everything is in good order. Should you notice anything amiss, please report it immediately so that the matter can be paid and rectified prior your departure. The damage deposit require is €500 or £500 payable in cash at arrival or through credit card.

5. Heated swimming pool

The outdoor overflow Swimming Pool can be heated up to 27°C

6. Use and Condition of Property

a) Accommodation is reserved only for the named persons. No other persons are permitted to stay in the property without our written permission nor shall it the maximum number for the property. Unauthorized over occupancy can result in penalty charges and/or immediate cancellation of the right to occupy the property. You agree not to use the property for any purpose other than as a private holiday residence for the people you list. If guests have friends staying in another property, at the same time, and they wish to invite them to use their facilities, they must first ask us.



b) Guests must behave with property and not cause damage, distress, danger or annoyance to other clients, neighbors or their property. If you do not comply with these responsibilities, we reserve the right to terminate your holiday immediately without any further liability. These circumstances will be treated as a cancellation by you. In these situations, no refund of any monies you have paid in respect of your booking will be made and we will have any liability to you as a result of this situation arising (including for example any costs or expenses you incur due to not being able to occupy the property, such as the cost of securing an alternative property/accommodation or the payment of any compensation to you). We will not be obliged to find any alternative accommodation for you. You must not damage any property with which you come into contact during your holiday, but if you do, you will be liable for the cost of repairs or replacements.

c) We are not responsible in any circumstances for unexpected events occurred inside or outside the property, in these situations no refund of any monies you have paid in respect of your booking will be made and we will have any liability to you as a result of this situation arising (including for example any costs or expenses you incur due to not being able to occupy the property, such as the cost of securing an alternative property/accommodation or the payment of any compensation to you). We will not be obliged to find any alternative accommodation for you.

d) Bed linen and towels are provided, and the property enough towels for your stay. Towels will be changed at the end of the 1st week is made new change of towels and linens. For stays longer than a week it is made a light cleaning at the end of each week, during the change of towels and sheets, but the cleaning maid's duties do not include cleaning the kitchen, utensils and equipment.

e) Smoking is not allowed inside the house.

f) The garden and pool lights work with a self-programmed hours of use system is not allowed to change the provisions.

g) The lights of the tennis courts can only be turned on until 10pm. Their use has an additional cost of 30 €/hour. It must be by appointment.

h) The furniture (beds, sofas, umbrellas, etc) arrangement cannot be not changed.

i) For your safety, although we have surveillance cameras (used only for this purpose), please always close the doors and windows of the villa. We are not responsible for your belongings.

j) To avoid the appearance of ants, it's important that every day take out the trash.

k) No pets on the property are allowed.

L) GOLF - PITCH AND PUTT RULES

Rule 1 - Only play with the Putter (putter stick).

Rule 2 - It is not allowed to play off the green (outside the grass, outside the area of the holes).

Rule 3 - It is not allowed to play from the Bunker (sand zone).

Rule 4 - The player will be held liable if he does not respect the rules. Approach strokes and / or medium and long-distance strokes are not allowed.

M) Rules to respect

- It's not allowed to change the layout of the furniture.



- It's not allowed to leave trash in the house, and in the exterior spaces, it's not allowed glass next to the swimming pool.
- Excessive ingestion of alcohol is not permitted.
- It's not allowed to use towels of the rooms in other areas of "IfVilamoura" or Beach.
- All furniture and linen in the room (sheets, pillowcases, towels, etc.) are in perfect condition. So that the parts that are found torn, burned or stained with products like oils, shoes, base or any other substance will automatically be given as out of use and debited from the breaking deposit.
- IfVilamoura will not be responsible for money or other objects of value that may disappear. Be sure to close the windows and close the main doors to the Building.
- It's not allowed the stay of people who are not part of the booking form.
- Don't make noise on outdoor areas in the period between 10pm and 8am.
